The successful bidder will have 18 months from closing date to cut and remove the timber. The sale will be awarded as soon as possible once the bids are opened and closing should take place within a reasonable time.

Care must be taken in felling and skidding to protect the remaining trees and so that erosion is kept to a minimum and tops and limbs are kept out of streams, fields and roads. Waterbars will be required on skid trails and roads where erosion is likely. At the conclusion of the contract, roads must be left in the same or better condition as existed when logging began. Georgia Best Management Practices will be followed. A Streamside Management Zone 25 feet on either side of the hollows will be maintained. 
